Manager said she received one bid and that bid is from Waste Management, 625 Cherrington Parkway, Moon Township, PA 15108. She said the bid is for a four year contract.

She said the bid is as follows:

- a.) Municipal solid waste transportation, disposal, and collection in unlimited containers per week and unlimited pounds per month.
