

**MINUTES**  
**UNION CITY BOROUGH COUNCIL SPECIAL MEETING**  
**MAY 25<sup>TH</sup>, 2010**

The Special Meeting of the Union City Borough Council was called to order at 7:24 P.M. by President Brumagin. The meeting was held at the City Building.

Councillors present were Brumagin, Bowes, Steadman and Tubbs. Councillors Hoban and McCrillis were absent.

Officials present were Borough Manager Cheryl Capela and Mayor Bill Hinkle.

There were no visitors present.

**COUNCIL TO APPROVE BIDS ON PAVING VARIOUS STREETS IN THE BOROUGH:**

President Brumagin said the Special Meeting is held this evening to approve bids on paving various streets in the Borough.

The Borough Manager said she received two bids. She said the first bid is from Russell Standard Corporation, P.O. Box 86, Union City, PA 16438. She said the bid is to furnish and apply subbase reclamation and 110# 9.5 MM leveling with a 9.5 MM superpave bituminous wearing course for Hemlock Street from Concord to a point and Washington Street from Parade Street to O'Dell Street at a bid price of \$82,536.76.

She said the bid also includes an Option 1 to furnish and apply subbase reclamation and 110# 9.5 MM leveling with a 9.5 MM superpave bituminous wearing course for East Street from Willow to East High Street at a bid price of \$20,491.56. She said the total bid price for all three streets is \$103,028.32.

She said the next bid is from Vincent Cross Paving, 11620 Lake Pleasant Road, Union City, PA 16438. She said the bid is to furnish and apply subbase

reclamation and 110# 9.5 MM leveling with a 9.5 MM superpave bituminous wearing course for Hemlock Street from Concord to a point and Washington Street from Parade Street to O'Dell Street at a bid price of \$77,944.82.

She said under Option 1 of the bid to furnish and apply subbase reclamation and 110# 9.5 MM leveling with a 9.5MM superpave bituminous wearing course for East Street from Willow to East High Street at a bid price of \$19,333.36. She said the total bid price for all three streets is \$97,278.18.

**MOTION TO APPROVE THE BID FROM VINCENT CROSS PAVING:** It was moved by Councillor Tubbs and seconded by Councillor Bowes to approve the bid from Vincent Cross Paving for all three streets at the bid price of \$97,278.18. Motion carried.

**ADJOURNMENT:** It was moved by Councillor Tubbs and seconded by Councillor Bowes to adjourn the meeting. Motion carried.

The meeting adjourned at 7:31 P.M.
