

**MINUTES  
UNION CITY BOROUGH COUNCIL SPECIAL MEETING  
AUGUST 30<sup>TH</sup>, 2007**

The Special Meeting of the Union City Borough Council was called to order at 7:00 P.M. by President Brumagin. The meeting was held at the City Building.

Councillors present were Brumagin, Balog, Bowes, Buell and Tubbs.

Officials present were Borough Manager Cheryl Capela and Mayor Paul Capela.

Visitors present were Leo Pfister, Susanne Ball, Kim Brumagin, Nancy Brumagin and Steve Sears.

**COUNCIL TO APPOINT AN INDIVIDUAL TO SERVE AS COUNCILLOR FOR THE SECOND WARD UNTIL THE FIRST MONDAY IN JANUARY, 2008:** A Resolution to appoint Dan Hoban as Councillor for the second ward to serve until the first Monday in January 2008 was read by the Borough Manager.

**MOTION TO APPROVE THE RESOLUTION APPOINTING DAN HOBAN AS COUNCILLOR FOR THE SECOND WARD TO SERVE UNTIL THE FIRST MONDAY IN JANUARY, 2008:** It was moved by Councillor Balog and seconded by Councillor Bowes to approve the Resolution appointing Dan Hoban as Councillor for the second ward to serve until the first Monday in January, 2008. A roll call vote was taken. All Councillors voted yea. Motion carried.

**MOTION TO APPOINT A TEMPORARY RESOURCE OFFICER:** It was moved by Councillor Tubbs and seconded by Councillor Bowes to appoint Jeremy Markham as the temporary Resource Officer for the Union City Area School District. Motion carried.

**COUNCIL TO APPROVE HIRING A FULL-TIME POLICE OFFICER:** Councillor Tubbs said the Borough Manager did receive the top three names from the Civil Service Commission. He said he would recommend hiring Jason Lantzy.

**MOTION TO APPROVE HIRING JASON LANTZY AS THE FULL-TIME POLICE OFFICER:** It was moved by Councillor Tubbs and seconded by Councillor Bowes to hire Jason Lantzy as a probationary full-time police officer effective September 5<sup>th</sup>, 2007. Motion carried.

**COUNCIL TO APPROVE THE RESOLUTION ON ESTABLISHING A FEE SECHEDULE FOR PEDDLING PERMITS:** The Resolution establishing a fee requirement for the licensing of peddlers, door-to-door sales persons and transient retail business was read by the Borough Manager.

**MOTION TO APPROVE THE RESOLUTION ESTABLISHING A FEE SCHEDULE FOR PEDDLING PERMITS:** It was moved by Councillor Bowes and seconded by Councillor Tubbs to approve the Resolution establishing a fee schedule for peddling permits. A roll call vote was taken. All Councillors voted yea. Motion carried.

**ADJOURNMENT:** It was moved by Councillor Balog and seconded by Councillor Buell that the meeting be adjourned.
